Declaration

I declare that during the event my self propelled exhibit will be covered by the minimum insurance requirements of the Road Traffic Act irrespective of whether my exhibit is licensed for use on the public highway or not, If my exhibit is not self propelled it will be covered by a Public Liability Policy and by a Boiler Explosion Policy. Both Policies have a limit of indemnity of not less than £5,000,000 any one accident, and Sparks and Ashes cover for not less than £100,000. I further declare that the boiler of any steam plant entered carries a current Boiler Inspection Certificate and that I will produce documentary evidence of such insurance and inspection to you before participating in the event. I further declare that the driver(s) hold a driving licence of the appropriate class and will produce, if required, such a licence and that the driver(s) have read the Border Counties Vintage Club Limited Code Of Good Practice.

I agree to produce, on request, an Inspection Certificate in accordance with the IEE regulations for any electrical equipment (i.e. generators, wiring, appliances)

All exhibitors to conform to the BCVC Ltd Code of Good Practice (available on request, send SAE to section steward)

I agree to operate my exhibit during the event and comply with the instructions of Stewards. In the event of a dispute the Event Organisers decision is final.

For administration purposes (principally to automate the production of labels) membership/exhibitor details are held on a personal computer. This information is only used for membership and or entry form distribution. In order to comply with the Data Protection Act, we are required to ask you to sign this declaration, stating that you do not object to your details being held on a computer. Thank you.
