Both policies have a limit of indemnity of not less than £2,000,000 any one accident, and sparks and ashes cover for not less than £100,000. I further declare that the boiler of any steam plant entered carries a current Boiler Inspection Certificate and that I will produce documentary evidence of such insurance and inspection to you before participating in the event. I further declare that the driver (s) hold a driving licence of the appropriate class and will produce, if required, such a licence and that he driver (s) have read the NTET Traction Engine Code Of Practice.

I agree to produce, on request, an inspection certificate in accordance with the IEE regulation for any electrical equipment (generations, wiring, appliances).

I agree to abide by the code of practice of the National Traction Engine Trust (NTET) and the societies written statement of safety policy.

I agree to operate my exhibit during the event and comply with the instructions of stewards. In the event of a dispute the event organiser/safety officer's decision is final.
